### Section 4 - First Aid Measures

#### Description of first aid measures

##### General Advice:

Remove contaminated clothing and shoes. Seek medical advice immediately and show safety data sheet or product label to the doctor, if possible.

### Section 5 - Fire-fighting Measures

#### Extinguishing media:

Suitable extinguishing media: water spray, dry powder, carbon dioxide, foam.

#### Specific Hazards arising from the substance or mixture:

Toxic gases such as hydrogen chloride, nickel oxides, molybdenum oxides, boron oxides may be formed in a fire situation. Carbon oxide, nitrogen oxides and oxides of phosphorus may form as well.

#### Advice for firefighters:

### Appropriate engineering controls:

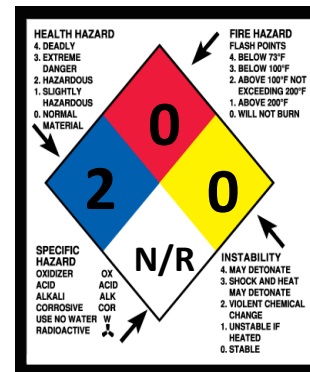
