LidoQuest 28-8-18 provides instant, efficient feeding of NPK for all types of turfgrass. LidoQuest 28-8-18 also contains Krystal Klear<sup>®</sup> micronutrients, the only micronutrients chelated with biodegradable BayPure<sup>®</sup>.

LidoQuest 28-8-18 is safe for all plants when used as directed.

LidoQuest soluble products are recommended as a supplement to a well-balanced fertilizer program only. Applications through drip or micro-jet irrigation are acceptable, however greater efficiency may be expected when making foliar applications during key growth stages.

#### Application Instructions

LidoQuest 28-8-18 is recommended as a supplement to a well-balanced fertilizer program only.

**Foliar Spray:** LidoQuest 28-8-18 may be applied with all types of ground spraying equipment.

For applications from ground rigs, apply 10 to 25 pounds in a minimum of 50 gallons per acre. Do not exceed a concentration of 10 lb. of LidoQuest 28-8-18 per 10 gallons of water.

For 1/4 lb. of Nitrogen/1,000 ft<sup>2</sup>, use a rate of 40 lb. per acre.

For 1/2 lb. of Nitrogen/1,000 ft<sup>2</sup>, use a rate of 80 lb. per acre.

1 lb. per 100 gallons of water is equal to approximately 350 ppm Nitrogen.

For best results, repeat every 7 to 10 days.

**Compatibility:** LidoQuest 28-8-18 is compatible with most common foliar pesticides and nutrients; however, USER ASSUMES FULL RESPONSIBILITY to ensure compatibility when tank mixing with other products.
