Prudent *Ready* GST is a concentrated fertilizer nutrient solution designed for the treatment of seeds.

Apply Prudent *Ready* GST at a rate of 6 ounces per 100 pounds of seed and dilute in sufficient water to provide adequate coverage of the volume of seeds.

It is recommended that Prudent *Ready* GST be mixed with 0.5 ounces of KaPre<sup>®</sup> RemeD8-WSP and 0.5 ounces of Nutrol<sup>®</sup> for every gallon of Prudent *Ready* GST.

### Compatibility

Prudent *Ready* GST is compatible with most common foliar pesticides and nutrients; however, USER ASSUMES FULL RESPONSIBILITY to ensure compatibility when tank mixing with other products. It is not recommended to use this product with other surfactants or adjuvants.
