KaPre® Embella Fertilizer Additive comprises a proprietary blend of a biodegradable sequestering agent, proteins, and, disaccharide and polysaccharide oligomers known as useful natural growth promoting substances.

Directions for Use

Apply 4 – 16 oz. of KaPre Embella per acre.

KaPre Embella can be shanked in, applied by drench, spray or air application, or can be injected into fertigation systems.

Application Instructions

Row Crops (Corn, Soybean, etc.): Apply 8-12 oz. per acre in furrow, as side-dress (with or without fertilizer) or on/near planting surface. Foliar-apply as needed at a rate of 4– 6 oz. per acre every 30 – 45 days.

Alfalfa: Soil-apply 8-12 oz. per acre at or near dormancy break, and, foliar-apply 4-8 oz. per acre 7-10 days after each cutting.

Cane & Vine Crops: Soil-apply 16 oz. per acre in early spring or in autumn.

Small Grains: Soil apply 16 oz. per acre at planting or near dormancy-break and foliar-apply 8-16 oz. per acre, as needed.

Nut Crops: Soil-apply 16 oz. per acre in early spring or post-harvest.

Citrus: Apply 16 oz. per acre twice per year via soil or drip application.

Turf: Soil-apply 8 - 16 oz. per acre at planting or sod-laying. Foliar-apply 8 - 16 oz. per acre every 14 – 28 days.

Compatibility

KaPre Embella is compatible with most fertilizers and pesticides but a jar test must be performed before tank mixing.

Storage and Handling

Store in a clean dry area at temperatures above 45 °F.
