General Information

KaPre® ProHuma humic acid may enhance micronutrient uptake. Proper timing and placement of product is important for desired results and is highly dependent on the stage of crop growth, soil fertility levels and environmental conditions.

Mixing Instructions

Mix 1 gallon of KaPre ProHuma in a minimum of 15 - 25 gallons water. When mixing with water, fill tank half full, add product then add the remaining water. When mixing, with pesticides, dilute product with water prior to addition of buffering agents & pesticides. Follow all directions and precautions on pesticide labels prior to mixing with product. Ensure adequate agitation in all situations. **Do not store diluted.**

Tank Mixes: Do not mix with pesticides or other chemicals without a compatibility test. An adequate test for compatibility involves mixing in a small container the proper proportions of the product with water and the other ingredients. Agitate and let stand for one hour. If a precipitate forms, then apply the products separately.

DO NOT mix product with Calcium Nitrate, Phosphoric Acid, Zinc Sulfate or other solutions with a pH less than 6.0.

DO NOT tank mix with carbonated based pesticides as efficacy will decrease.

Application Instructions

Pre-Plant and Sidedress: Apply 2.5 - 7 quarts (0.625 - 1.75 gallons) per acre in at least 25 gallons of liquid fertilizer.

Direct Seeding: Apply 2.5 - 5 quarts (0.625 - 1.25 gallons) per acre banded on the seed at planting.

Starter Fertilizer: Apply 2.5 - 5 quarts (0.625 - 1.25 gallons) per acre with starter pop-up fertilizers.

Water Run: Apply 2.5 - 7 quarts (0.625 - 1.75 gallons) per acre in irrigation water.

Drip Irrigation and Micro Sprinklers: Apply 2.5 - 7 quarts (0.625 - 1.75 gallons) per acre. Dilute KaPre ProHuma at a ratio of 0.625 gallon to 1.75 gallons of water prior to injecting into the irrigation system.

Transplant Water: Apply 2.5 - 7 quarts (0.625 - 1.75 gallons) per acre in the transplant solution.

Foliar Application: Apply 2.5 - 4.0 quarts (0.625 - 1.0 gallon) per acre by ground or air with foliar fertilizers. Apply as needed.

Tree Crops: Apply 2.5 - 5 quarts (0.625 - 1.25 gallons) per acre in sufficient water to cover (minimum of 50 gallons of water per acre).

Turfgrass: Apply 8 - 12 quarts (2 - 3 gallons) per acre or 5.85 - 9.0 fl. oz. per 1,000 ft².
