General Information

RemeD8[™]-WSP soil inoculant is formulated specifically for greens, tees, fairways, sports turf and lawns of all types. The microorganisms contained in RemeD8[™]-WSP have been shown to increase the availability of certain plant nutrients, enhance nutrient cycling, as well as, improve both root and soil structure.

RemeD8[™]-WSP is not a pesticide and will not replace standard pesticide applications.

Application Rates and Timing

Greens, tees and other low-cut turf: Apply one 8 oz. packet of RemeD8[™]-WSP per 1.0 to 1.25 acres. Apply every 14 days throughout the season.

Fairways, roughs, sports turf and other high-cut turf: Apply one 8 oz. packet of RemeD8[™]-WSP per 2.0 to 2.5 acres. Apply every 14 days throughout the season.

Tank Mixes

RemeD8[™]-WSP should be the first component added to the water in the tank. Fill the tank with 25-50% of the required water. While maintaining agitation, add packet of RemeD8[™]-WSP. Wait until the packet has completely dissolved before adding other fertilizers or chemicals to the tank.

Do not mix with other chemicals without a compatibility test. An adequate test for compatibility involves mixing in a small container the proper proportions of the product with water and the other ingredients. Agitate and let stand for one hour. If a precipitate forms then apply the products separately.

Storage and Handling

RemeD8[™]-WSP contains live spores of naturally occurring bacteria. Spores are live and may be damaged when exposed to high temperatures. The live organisms contained in RemeD8[™]-WSP require specific storage conditions to ensure viability and product performance. To maintain viability:

- * Store unopened containers in a cool, dry place, away from sunlight and heat sources.
- * Minimize temperature fluctuations. For optimal results, do not store above temperatures of 75°F.
- * Use within one year from the date of manufacture. This expiration date is valid for unopened containers stored according to the conditions listed above.
