#### GENERAL INFORMATION

Vibrant® Green specialty fertilizer is formulated with premium sources of NPK to support vigorous turf, trees, and ornamentals throughout the growing season. Vibrant Green is formulated with slow-release nitrogen. Vibrant fertilizers contain only patented Krystal Klear® chelated micronutrients to support efficient nutrient uptake and help reduce abiotic stress. Use Vibrant Green when a balanced approached to sustained turf green-up is desired, or once the turf or plant is established to aid in its growth and development. Vibrant products are ideal for soil or foliar spray applications for turf and ornamentals. Vibrant Green is compatible with fungicides, herbicides, and insecticides and can be mixed and sprayed in one application.

#### APPLICATION INSTRUCTIONS

#### **Turf applications:**

Vibrant Green can be applied throughout the growing season beginning in early spring and continuing through the late fall.

Cool Season Grasses

Maintenance applications: 4 to 5 oz per 1,000 ft<sup>2</sup>. Severe deficiencies: 6 to 8 oz per 1,000 ft<sup>2</sup>.

Warm Season Grasses

Maintenance applications: 4 to 8 oz per 1,000 ft<sup>2</sup>. Severe deficiencies: 6 to 8 oz per 1,000 ft<sup>2</sup>.

#### Trees, Shrubs and Ornamentals:

Vibrant Green can be applied as needed throughout the year. Applications should be made at rates of 1.0 - 1.5 gallons of Vibrant Green per 100 gallons of spray solution. Apply 5 gallons of spray solution per diameter inch. Applications should be made as needed throughout the growing season.

#### PRECAUTIONARY STATEMENTS:

Do not handle until all safety precautions have been read and understood. Keep away from heat, sparks, open flames, hot surfaces and other ignition sources. No smoking. Avoid breathing fume/mist/vapours/spray. Wash skin thoroughly after handling. Do not eat, drink or smoke when using this product. Use only outdoors or in a well-ventilated area. Wear protective gloves/protective clothing/eye and face protection.

#### STORAGE INSTRUCTIONS

Vibrant Green is a chelate with low corrosivity. It is recommended that Vibrant Green be stored in fiberglass, polyethylene, or polyolefin. Do not stack pallets.

#### MIXING INSTRUCTIONS

Tank Mixes: Do not mix with pesticides or other chemicals without a compatibility test. An adequate test for compatibility involves mixing in a small container the proper proportions of the product with water and the other ingredients. Agitate and let stand for one hour. If a precipitate forms, then apply the products separately.

Vibrant Green will disperse in water with little or no agitation. Many pesticides can be applied with Vibrant Green. Follow this mixing sequence: Water, Vibrant Green and pesticide.
