GENERAL INFORMATION

Prudent[®] GREEN is a patented liquid fertilizer enhanced with a concentrated green pigment to provide both nutritional support and immediate visual color. The pigment is designed to mimic the look of actively growing grass, improving turf appearance and aiding in uniform spray application. This product is especially useful when turf is under stress or when rapid green-up is desired.

DO NOT exceed a maximum concentration of 4 ounces of product per gallon of water in the spray tank.

APPLICATION INSTRUCTIONS

Foliar Applications:

Prudent[®] GREEN may be applied with all types of ground spraying equipment. DO NOT exceed a maximum product rate of 4 ounces of product per gallon of water in the spray tank.

Turfgrass:

Apply 1 to 4 ounces per 1,000 ft². Applications can be made in the Spring and Fall, or as needed when turf is under heavy stress.

For best results, spray when the turf is in an active growing stage, after irrigation or rainfall. Spray early mornings or later afternoons.

STORAGE INSTRUCTIONS

AVOID FREEZING. It is recommended that Prudent GREEN be stored in fiberglass, polyethylene, or polyolefin. Do not stack pallets.

Do not apply if a heavy rain is expected. Do not apply near water, storm drains, or drainage ditches or to any impervious surface. Only apply to intended application area.
